Pricing is subject to change at the beginning of each service year. **If you are 65 years or older, you are eligible for a senior discount. In order to have the senior discount applied to your account please send in a copy of your driver's license so we can verify your age, for the discounted price please contact the office.** Payments are due 25 days from the date of billing. For your convenience, payments can also be made the following ways:

- **Walk-in payments** of checks, money orders or exact change ONLY are accepted at our office.
- **Online payments** can be made at [www.fwllc.net](http://www.fwllc.net) (from your debit or credit card account). If you do not have login information such as an Account Number or Password, please contact our office and we can help.
- **Recurring Automatic ACH payments** can be made (from your checking or credit/debit card account). A Recurring Payment Authorization Form is attached for your convenience. Interested parties should mail the form and all supporting documentation back to us once completed at our General Mailing Address.
- **Phone Payments** can be made by calling our Customer Service Department (from your debit or credit card account). Processing fees may apply.

**Refuse Preparation**

At Fayette Waste, LLC we take pride in providing reliable and dependable service to our customers. But we need your cooperation to ensure your trash is picked up timely.

**Pick-up Day:** Thursday and Friday: Trash will be picked up at the curb or at a maximum of five (5) feet behind the curb line.

Please place your securely closed garbage bags at the curb the night **BEFORE** your scheduled trash pick-up day. Trash can usage (with a lid) is strongly recommended to help eliminate unnecessary mess and to help our employees at the time of collection. Trash may be placed in a trash can or outside of a trash can. Your trash service with Fayette Waste, LLC permits you to place **six (6) bags per week** at the curb.

**We DO NOT and WILL NOT pick up loose garbage.** All trash must be properly and securely bagged.

#### **Bulk Items**

Should you need to have a bulk item (anything that is outside of the 6 bags per week and that is not considered everyday household trash) picked up, please call our office in advanced of your pick-up day to schedule these items. Once scheduled they will be picked up on your next normal pick-up day with your regular scheduled service. Additional fees may apply for bulk items.

#### **Spring/Fall Cleanup**

Two times per year Fayette Waste will schedule a Cleanup Day, one in the Spring and one in the Fall. Your township will be notified of such scheduled days. Scheduled days will also be noted on the second (2<sup>nd</sup>) and fourth (4<sup>th</sup>) quarterly invoices. During these scheduled days you are permitted to place two (2) large items and up to an additional 6 bags at the curb.

#### **Items that Cannot Be Collected**

- Tires & Car Parts
- Construction/Building Material\*
- Light Bulbs
- Batteries
- Paint Cans w/Paint Inside\*
- Electronics
- Yard Waste
- Liquids
- Items Containing Anti-Freeze Or Freon\*

#### **\*Please make note of these additional terms of services:**

- Refrigerant needs to be removed and proof of removal must be attached (sticker & invoice) for any anti-freeze or freon items
- Paint must be dried with lids off
- Carpet Must be cut to 4-foot lengths & bundled
- Trash bags should NOT exceed 25 lbs

#### **Holiday Schedule**

Fayette Waste, LLC is closed for service on the following holidays:
